Fletcher writes, lectures and works internationally. She generates opportunities for IHCD and has broad oversight of all educational programs as well as consulting and design services. Her research focus is integrating data from contextual inquiry research findings into design solutions in higher education, culture, workplace, healthcare, multifamily housing and the public realm.

Ms. Fletcher is Councilor for the International Association for Universal Design (IAUD) in Japan and has created an international inclusive design benchmarking project for the government of Singapore. She leads the initiative to create a new digital resource on accessibility and universal design for the US National Endowment for the Arts, National Endowment for the Humanities and Institute for Museum and Library Services. Ms. Fletcher has a master's degree in ethics and public policy from Harvard University. In addition to numerous honors, she received The Boston Society of Architects' Women in Design award in 2005. She co-chairs the Design Industry Group of Massachusetts and is a member of the Board of Trustees of the Boston Architectural College.
