

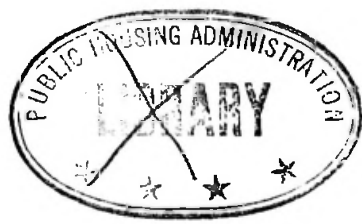

Postage stamps are not acceptable.
