Background: What is EJ?

ENVIRONMENTAL JUSTICE (EJ) | Ensuring equal protection from environmental and health hazards and providing equal and meaningful opportunity to participate in the decision-making process to achieve a healthy environment.

JUSTICE40 INITIATIVE | The Federal Government has made it a goal that 40 percent of the overall benefits of certain Federal investments flow to disadvantaged communities that are marginalized, underserved, and overburdened by pollution (EO 14008)

LINK TO HUD'S MISSION | <u>Addressing EJ</u> is at the core of HUD's mission to create strong, sustainable, inclusive communities. (<u>HUD</u>)

EJSCREEN | EJ Mapping and Screening Tool developed by the Environmental Protection Agency (EPA); Small levels of geography

Approach combines environmental and demographic indicators

- 12. Wastewater Discharge












EJ Screen Lead Paint Index and HUD-Assisted Households in Des Moines, Iowa
