

Do your streets need a diet? Are you experiencing unwanted growth? Or maybe a population hemorrhage? Do you need an infill transplant? Have any other built environment ailment?

The EPA, along with a team of national smart growth experts, has created the elixir to your planning and development health ills. It comes in a Building Blocks Toolbox of smart growth-related concepts and strategies that can assist your community in creating better public spaces, more vibrant, mixed-use districts and a healthier attitude toward what it means to be a sustainable community.

The toolbox contains dozens of resources that can assist communities of all sizes and shapes. During the conference, the EPA's Office of Sustainable Communities will be holding 20-minute "office hours" to match your ailment with a prescription from the toolbox.
